The Memorandum of Understanding (MOU) establishes the following:

FIRST: OBJECTIVE OF THE AGREEMENT:

To establish a mutually beneficial relationship built on academic, scientific, technological and cultural cooperation. Areas of cooperation between the Two institutes (hereafter referred to as PARTNERS) include the exchange of researchers, students, publications, academic programs and research projects with Siemens Centre of Excellence available with LEC-Morbi (degree side).

SECOND- GOALS AND FORMS OF COOPERATION:

The signing institutions agree to provide opportunity, as appropriate, for the following activities towards the completion of the objectives of this MOU:

1. Exchange of researchers with the objective of offering courses and realizing research projects in areas mutually agreed upon by both partners through prior invitation and in accordance with the procedures and expectations established by each institute and specific department.
2. Exchange of under graduate and graduate students with the objective of enrolling students in courses appropriate to their area of study and need of the Time.
3. Support reciprocity in institute extension activities of common interest.
4. Exchange of scientific publications, study programs, academic projects, courses information seminars, conferences and any other data and information of common interest.
5. Develop joint research projects and joint publications.
6. All joint activities will be realized through the mutual agreement and clearly established conditions and mutual obligations of the appropriate institute entity.

THIRD- IMPLIMENTATION OF THE MEMORANDUM OF UNDERSTAINING:


The objective of the MOU will be implemented and regulated in the following manner:


1. Student Exchange:
 - a. A. Under graduate and graduate students may enroll in courses in the department and school of their choice, with the exception of few courses and select graduate level course. Annual imbalance in the exchange shall be monitored and addressed in the wide academic interests.

- b. Nominations including a statement of student's academic records to date and the application forms required by each institution shall be exchanged via the appropriate offices of the institutions.
 - c. The exchange students will have the same rights and obligations as degree seeking students at the host institution, and they will follow the norms and regulations of the host institution.
2. Research and Resources:
Promote research and realize cooperative projects, giving priority to interdisciplinary works.
- a. As appropriate and mutually agreed upon by both institutes, partners share financial resources necessary for the completion of joint programs.

FOURTH – DURATION AND RECINDENCE OF MOU

- a. The agreement shall come into effect on 12/02/2018. Changes to this agreement shall be made by mutual consent between both institutions. In cases of disagreement, the institute wishing to depart from the agreement shall, wherever possible give six months notice of its intention to do so. The agreement shall be reviewed after the period of five years.
- b. In order to promote further scholarly exchange both institutions shall actively consider the exchange scholars. Such exchange shall be the subject of ad hoc consultation in the future in accordance with needs and feasibility.
- c. Correspondence about this agreement shall be conducted between the student sections of each institute.





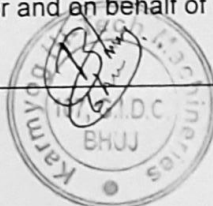
